# **Celebrating wetlands**

According to the UN, wetlands are the unsung heroes of the world. They store more carbon than any other ecosystem and could be instrumental in helping us adapt to climate change.

Despite their potential, wetlands remain the world's most threatened ecosystem. With 35% of global wetland area lost since 1970, they are disappearing three times faster than forests, leaving more than a quarter of wetland species threatened with extinction.

**World Wetlands Day** is celebrated every year on 2 February to raise global awareness about the vital role of wetlands for people and planet.

Our Murray River floodplains are home to several wetlands recognised as important, both nationally and internationally. Unfortunately,

as we've changed the way the river flows over time, we've reduced the flows needed to keep these wetlands healthy.

The infrastructure we plan to build at these sites will allow natural flows into the floodplains, as well as being able to hold water there for as long as needed to support the environment, before returning it to the river.



# **Preparing Planning Scheme Amendments**

Each municipality in Victoria is covered by a planning scheme that regulates the use, development and protection of the land. A planning scheme can only be changed by a formal amendment process. This usually consists of public exhibition of the draft amendment, followed by a panel review and submission to the Minister for Planning for a decision.

The works planned under VMFRP trigger several planning approval requirements. Draft planning scheme amendments are currently being prepared for the Campaspe, Gannawarra, Swan Hill and Mildura planning schemes. They will be exhibited concurrently with the EES and ER documentation later in 2022, giving the community the opportunity to have their say.

Draft planning scheme amendments are one part of a package of approvals needed before VMFRP construction can begin.

# **Floodplain** cultural values

All of the Murray floodplains have significant cultural value for the Indigenous community, including the use of water and Country. This is why Traditional Owners and Aboriginal interested parties are carrying out cultural heritage assessments at each of the VMFRP sites.

Getting water onto river country is a stated aspiration of Indigenous groups along the Murray. In partnership with Traditional Owners, work was undertaken to acknowledge cultural values and uses of northern Victorian river country through discussions as part of Victoria's Northern and

### Murray Water Resource Plan undertaken as part of the Basin Plan.

# **Engaging with the community**

VMFRP project team members have been out and about after the summer break. In February, we also visited the Swan Hill and Cohuna Farmers Markets, as well as drop-in sessions at the Wood Wood and Hattah stores. It was great to meet so many people and listen to their ideas and views on the Murray floodplains. Building on the work before Christmas, we have scheduled meetings for March and April with our stakeholder and community advisory groups. These groups are made up of local people that have generously put their hand up to help shape the project.

These meetings will focus on gathering community insight into the technical studies being completed for the Environmental Effects Statements and Environment Reports (EES/ER). This input will add to discussions held with land managers and specialists which have helped shape our investigations. This feedback is being used to develop the EES/ER documentation ready for public exhibition later this year.

**Ecological monitoring** is well underway to understand the health of VMFRP floodplain ecosystems and set baseline data before VMFRP watering begins in 2024. This will enable us to measure the impact and effectiveness of environmental watering programs at the nine sites.

The Mallee and North Central CMAs are working with experts such as the Arthur Rylah Institute (ARI) to undertake monitoring across all nine

VMFRP sites. We even had a mention in **ARI's February newsletter!** 

Monitoring data is being used to inform the EES and ER documentation.
